One of the reasons that we have a Summer Conference in July is to pass the budget for the ensuing year. By holding the first Council meeting immediately after the Convention, we will reduce expenses by eliminating the Summer Conference while passing the new budget for the ensuing year. The Council of Administration receives the budget proposal at the planning meeting, which is usually held in May. They discuss the budget at the planning meeting and they make changes, if appropriate. The Council members are given a copy of the budget to take with them so that they are familiar with the budget when we vote on it.

In the year 2012 the National Convention moves to the third week in July. That means that our State Convention will move to the second or third week in June so that we will be able to submit National Bylaws changes to our National Organization for distribution in accordance with the provisions of the National Bylaws. This is another reason that we need to do

Therefore, I am submitting a Department of Michigan Bylaw Amendment to Article XIII for consideration again at the 2010 State Convention. The amendment is printed in this issue of the *Michigan Overseas Veteran*. Your support is needed to pass this amendment.

We are facing a \$56,000.00 cut from our National Headquarters guarantee program. Because of the decrease in donations from our membership to the National programs, we have no choice but to make cuts at Department. All expense items will be considered and concessions will be proposed. We need your support with donations. This is your organization and we need to make sure that it stays solvent.

There is absolutely no doubt that our World War II and Korean War members and their spouses have been the most

John F. Gwizdak Commander-in-Chief, 2000-2001 Veterans of Foreign Wars of the United States

John F. Gwizdak of Woodbury, Georgia, was elected VFW's Commander-in-Chief at the organization's 101st National Convention in Milwaukee, Wisconsin on August 25, 2000. Gwizdak is the second Georgian to hold this office.

Born in Revloc, Pennsylvania and raised in Carrolltown, Gwizdak enlisted in the U.S. Army in 1958. In 1968, he attended Officer Candidate School and was commissioned a second lieutenant. He retired in 1978 in the rank of captain.

His service career included three tours in Germany, including a rotational tour in Berlin, and in Vietnam with Co. E, 4th Bn., 12th Infantry, 199th Light Infantry Brigade. Starting out as a heavy mortar platoon leader, he eventually assumed command of Company E based at Long Binh. The unit operated out of Camp Frenzell-Jones. He held the distinction of having served in all leadership positions,

from squad leader to company commander of an infantry company. He also was inducted into the United States Army Officer Candidate School Hall of Fame.

His military awards and decorations include the Legion of Merit, Meritorious Service Medal, four awards of the Bronze Star Medal (including one for valor), Purple Heart, Vietnam Cross of Gallantry with palm device, Army Commendation Medal (3), Army of Occupation Medal (Berlin), Vietnam Campaign and Service Medals, Good Conduct Medal (3), Armed Forces Reserve Medal, National Defense Service Medal, Combat Infantryman's Badge, Parachutist Badge and Drill Sergeants Badge.

Department Service Officer SUCCESS STORY

This issue's success story centers on a veteran's fight to have his Post-Traumatic Stress Disorder (PTSD) recognized by the VA.

In 2003, the veteran filed a claim for service connection for anxiety. The VA first denied the claim in May 2003, stating the veteran had never been treated for a mental health condition while in the service.

The veteran then filed a claim for depression due to another service-connected condition and his claim was denied.

In September 2006, the veteran requested his claim be amended to include yet another condition – PTSD. The veteran outlined how he had been traumatized by a brutal attack while stationed in Germany. The veteran reported, at the time, he suffered a fractured nose and jaw.

In February 2008, the VA Regional Office finally denied the PTSD. The VA stated there were no military records showing treatment from a fractured nose or jaw. However, the VA conceded the veteran was treated and had "butterflies" (bandages) under both eyes from the

assault. Since there were no records of a fractured jaw or nose, the VA stated the veteran's stressors could not be verified.

In 2009, the veteran re-opened his claim for service connection for PTSD. The veteran provided a statement regarding the assault. The veteran provided crucial information regarding the specifics of the attack to include a name, a date, and the exact location where the incident happened. In addition, the veteran was able to provide a statement from a fellow soldier who had seen the veteran two days after the attack. The witness outlined that the veteran had two black eyes and his face was all black and blue.

The veteran requested a personal hearing at the Detroit VARO and the hearing was conducted in July 2009. Our staff member was present at the hearing with the veteran. The Advocate led the veteran through a series of probing questions to bring out the specific details surrounding the attack. It was important to bring all the facts to light due to the complexity of the case.

Over the course of time, the veteran had claimed service connection for three mental health conditions: anxiety, depression and PTSD. Though they are separate conditions, all mental health conditions are rated under the same criteria in the VA Rating Schedule.

There are times when a personal hearing is beneficial to the merits and validity of the case. In this case, our staff member was able to extract delicate and important aspects that previously were not considered by the VA. As a result, the Decision Review Officer granted service connection for PTSD back to June 2003. The importance of having a competent Advocate resulted in a retroactive payment of \$104,788 in February 2010.

Advocating for Others

In the last issue, we explained in depth the effects of SB 250 and the requirements to petition the State of Michigan for grants. We are please to report that our coalition was awarded the two large grants. At the time of the last article, we indicated that we would also be applying for the two small grants.

We felt as a coalition that our history of providing exemplary advocacy service to the veteran community in the State of Michigan was, and is now, second to none. We based this fact on our high level of training, credibility and our willingness to not compete with one another, but to complement one another as we embark on a new way of doing business. We also felt that the level of expertise and the combined resources the coalition offers will increase the overall rate of return and quality of life issues to those we serve here in the State of Michigan.

At the Advisory Board meeting On April 1, 2010, and after careful deliberation by the Department of Military and Veterans Affairs, the coalition was awarded the small grant that primarily deals with the Michigan's Lower Peninsula 1-131 corridor from Emmet County to the Indiana-Michigan border. The AMVETS was awarded the small grant in an area bounded by Midland/Bay City/Saginaw on the North, US 127 on the West to the Ohio-Indiana border.

This will be a new way of doing business inasmuch as 60% of our operation will be in the field, with only 40% in the Detroit Regional Office. This requirement has been imposed by the State of Michigan to have more boots on the ground, especially to those underserved areas of Michigan. As one might imagine, this will result in doing more with less. There will be growing pains due to the anticipated increase in claims and overall work activity. However, as in the past, we will survive and the coalition will work together so that our veteran community here in Michigan will get the maximum benefit from the Department of Veterans Affairs that is provided within the perimeters of law.

The proposed regulations for the following conditions were posted in the Federal Register on March 25, 2010. Ischemic heart disease (including coronary artery disease), Parkinson's disease, and B cell leukemia's (such as hairy cell leukemia). Of course, the condition that will produce the most claims will be Ischemic heart disease (IHD).

For purposes of the proposed regulation, the term "IHD" includes, but is not limited to, acute, sub acute, and old myocardial infarction; atherosclerotic cardiovascular disease including coronary artery disease (including coronary spasm) and coronary bypass surgery; and stable, unstable and Prinzmetal's angina. Since the term refers only to heart disease, it does not include

hypertension or peripheral manifestations of arteriosclerosis such as peripheral vascular disease or stroke.

Nehmer v. U.S. Department of Veterans Affairs, Civ. Action No. 86 6160 (N.D. Cal.) (TEH) (Nehmer) is a longstanding class action (originated in 1986) on behalf of all veterans and survivors of veterans eligible to claim VA disability compensation benefits based on exposure to herbicides in the Republic of Vietnam during the Vietnam era. In 1989, the U.S. District Court for the Northern District of California invalidated a 1985 VA regulation governing claims based on herbicide exposure. In 1991, the parties entered into a stipulation to provide for readjudication of class members' claims and payment of retroactive benefits, if warranted. Since that time, the district court has issued a series of orders interpreting the 1991 stipulation to impose ongoing duties on VA. Consistent with those orders, whenever VA identifies a new disease that is associated with herbicide exposure and adds a new disease to its regulatory list, it must identify and readjudicate any previously filed claims by the class members involving that disease and, if warranted under VA regulations governing Nehmer awards, must pay benefits retroactive to the date the prior claim was received by VA to the veteran or, if the veteran is deceased, to the veteran's surviving spouse, child or parents. In July 2007, the U.S. Court of Appeals for the Ninth Circuit rejected VA's position that its duties under the Nehmer stipulation have ended and held that VA's duties extend through at least 2015. Nehmer v. U.S. Dept. of Veterans Affairs, 494 F.3d 846, 86263 (9th Cir. 2007). Accordingly, the requirements of the Nehmer court orders for review of previously denied claims and for retroactive payment will apply to the proposed new presumptions, to the extent consistent with the court orders and 38 CFR 3.816, the VA regulation implementing those orders.

In 2010, approximately, 86,069 Vietnam beneficiaries as of August 2009 will be eligible to receive retroactive payments for the new presumptive conditions under the provisions of 38 CFR 3.816 (Nehmer). Of this total, 69,957 are living Vietnam Veterans, of which 62,206 were denied for IHD, 5,441 were denied for hairy cell or B cell leukemia, and the remaining 2,310 for Parkinson's disease. Of those previously denied service connection for the three new presumptive conditions, 52,918, or nearly 76 percent, are currently on the rolls for other service-connected disabilities.

A Plea from A Concerned Veteran

I joined the army in 1966 and served one tour of duty in Vietnam and I want to let everyone know what's happened to me since I left the military in 1968. One Saturday night in 2004, I went to dinner with my wife. While we sat and ate our meal, I noticed that I was sweating so bad that a new suit that I was wearing, was all wet and turning white from the salt in my body. On the following Monday, I went to see my doctor. After leaving his office, I contacted our VFW Service Office in Detroit to let

them know what had happened.

I filed a claim for diabetes, and later reopened my case because I was prescribed medication and found that I also had peripheral neuropathy in both legs.

In 2006, I went to work and when I got there, I couldn't remember how I got there or who anyone was or even what trade I was involved in. I once again went to my doctor who sent me to two different specialists, and they both said I had several incidents of a

Comrades and Sisters,

Hello from the U P. This will probably be my last article for the *MOV*. I was going to say all the things about reports, but I am going to stress women in the military and women veterans of the United States of America. First, I want to thank all women vets from every branch of the service – past, present and future. We VFW members salute you. We thank you for your service, sacrifice and your courage.

Now some facts. During WWII, June 1945, Army nurses in Europe peaked at 17,345. Of the 215 Army nurses who died on foreign shores, 16 were killed as a result of direct enemy action. Of those, six were killed aboard the hospital ship *Comfort* when it was attacked by a Kamikaze off Leyte Island on April 28, 1945 during the battle of Okinawa. Another six died at Anzio, and four others were KIA as flight nurses. However, no WAC's lost their lives to enemy action. Total female deaths during WWII:

ANC 215, WAC 181, Waves 69, NNC 40, WASP 38, for a total of 543

During the Korean War, at the end of 1950, 250 Army nurses were in Korea. 10% of Army nurses worked in evac hospitals, 8% in field hospitals, 7% in installation hospitals, 5% aboard planes and ships. The vast majority, 70%, were attached to MASH (Mobile Army Surgical Hospital) units. MASH hospitals, set up to handle 60 or more patients just behind the front lines, had 17 nurses and 19 doctors. Surgery could be done quickly, thus saving

lives. Then patients were sent by ambulance or truck to evacuation hospitals. With 30 nurses and 30 doctors there, they could treat more than 200 patients.

During the Vietnam War, 6,250 nurses served in country. The war was a wrenching experience that persisted long beyond its aftermath. eight Army nurses have their names recorded on the Vietnam Wall: CPT Eleanor Grace Alexander, 2LT Pamela Dorothy Donovan, 2LT Carol Ann Elizabeth Drazba, LTC Annie Ruth Graham, 2LT Elizabeth Ann Jones, CPT Mary Therese Klinker, 1LT Sharon Ann Lane and 1LT Hedwig Diane Orlowski. About 700 WAC's served in Vietnam between 1966 and 1972.

When the war erupted in the Persian Gulf in 1991, some 40,782 U.S. military women were deployed to the Middle East. At the time, this was the largest single deployment of women in U.S. history. Women continue to forge new roles in Iraq and Afghanistan. Today's wars see more and more women taking up arms against the enemy.

We have a job to do. The VFW must get out and bring some, or all of these female veterans into our midst. They are a part of our future. The statistics show more and more women are playing a bigger role in the military.

Now all that being said, I wish to thank all VFW members for all the support I received in the last two years as the Commander of the 14th District of Michigan. Thank you, comrades.

Remember: Keep 'em rolling out to sea.

VFW Urges Passage of Veterans Jobs Bill

Corporate America the key to stemming rampant unemployment rate

WASHINGTON, April 20, 2010 – The Veterans of Foreign Wars of the U.S. is backing legislation introduced today by Sen. Patty Murray (D-Wash.) to create a veterans jobs bill to help ease the rampant unemployment rate among Iraq and Afghanistan veterans.

“The nation’s economy is showing signs of improvement, but the unemployment rate of current war veterans is accelerating in the wrong direction,” said VFW National Commander Thomas J. Tradewell, Sr., of Sussex, Wis. “We believe Senator Murray’s bill will help address many of those concerns and impediments to employment.”

According to the Department of Labor, there are more than 1.1 million unemployed veterans, a quarter-million of whom are Iraq and Afghanistan veterans, with unemployment rates of 30.2 percent for age 24 and younger, and 17.9 percent for ages 25 to 34. The national unemployment average is just below 10 percent.

In testimony last week before the House Veterans Affairs Subcommittee on Economic Opportunity, the VFW said Washington cannot solve the veterans’ unemployment epidemic alone, but Washington can – and must – do a better job of selling veterans to corporate America.

“The federal government must become a veteran’s greatest cheerleader,” said Tradewell, who is very supportive of Murray’s bill to expand counseling, training and placement services, as well as entrepreneurial opportunities, because

“veterans hire veterans.”

The VFW also wants federal incentives increased to entice more businesses to hire more veterans.

One such incentive, for example, would be to double the \$2,400 and \$4,800 Work Opportunity Tax Credit for businesses who hire veterans and disabled veterans, respectively, as well as eliminate the program’s five-year window that currently excludes 765,000 unemployed veterans from being eligible.

In addition, the VFW national commander wants America’s veterans who are in the corporate world to use their veteran status as a bully pulpit to push “Veterans First” in boardrooms across the country.

“A young platoon sergeant or lieutenant is in a foreign country right now helping a small community get back on its feet – and they are doing it in a different language and armed primarily with the common sense in their head and the people skills they learned in the military. Just imagine what that can-do attitude could bring to America’s business community if just given a chance,” said Tradewell.

“Our greatest generation returned home from World War II to become the scientists, scholars and captains of industry who led our nation’s tremendous era of growth in the second half of the 20th century. That is exactly what America’s newest greatest generation is capable of, and it all begins with one job and one employer who believes that those we entrust to protect our nation can also be trusted to run their companies.”

Senate Passes TRICARE Protections

House action still needed to recognize VA healthcare

WASHINGTON, April 13, 2010 – With the Senate passage of HR 4887 last night, all military TRICARE programs will soon be recognized as meeting minimum essential coverage standards under the new national healthcare law, according to the national commander of the Veterans of Foreign Wars of the U.S.

Though a great victory for more than 9 million military families and retirees, Thomas J. Tradewell, Sr. cautioned against celebrating until the House acts on S. 3162, which was introduced by Senate Veterans Affairs Committee Chairman Daniel Akaka (D-HI) to recognize and protect all VA healthcare programs, too.

“There are a few more parts to this mission, which won’t be complete until the House passes S. 3162 and the president signs both bills,” he said.

The VFW has been aggressively working since mid-March to ensure the new national healthcare law recognizes and protects all the healthcare programs provided by the Departments of Defense and Veterans Affairs.

“National healthcare will help many veterans who are ineligible for DoD or VA care,” said Tradewell, a combat-wounded Vietnam veteran from Sussex, Wisconsin, “but missing from the original legislation was language that specifically recognized all military TRICARE and VA programs as meeting minimum essential coverage standards. That meant standalone legislation was required to protect all the healthcare programs provided by the nation’s two largest federal departments.”

House Armed Services Committee

Chairman Ike Skelton (D-MO) was the first to act with the introduction of H.R. 4887. His bill was necessary because the national healthcare legislation, as written, only recognized TRICARE for Life, and excluded a half dozen other TRICARE programs, as well as the health plan provided to DoD non-appropriated fund employees. H.R. 4887 passed unanimously 403-0. Senate Armed Service Personnel Subcommittee Chairman Jim Webb (D-VA) quickly introduced S. 3148 as a companion to Skelton’s H.R. 4887, which cleared the Senate last night.

Senate VA Committee Chairman Daniel Akaka (D-HI) introduced S. 3162 to recognize and protect all VA programs. His bill remains necessary because the national healthcare legislation, as written, only recognizes veterans covered under chapter 17 of Title 38, and excludes other Title 38 recipients, to include widows and dependent children. S. 3162 passed the Senate March 26, but has yet to move to a vote in the House.

“Bill language is extremely important because it becomes the law of the land,” said Tradewell, who applauded the efforts of Skelton, Webb and Akaka, as well as Senate VA Committee ranking member Richard Burr (R-NC), House VA Committee ranking member Steve Buyer (R-IN), and House Armed Services Committee ranking member Buck McKeon (R-CA).

“The VFW salutes these true champions in Congress for ensuring all the hard earned DoD and VA healthcare programs for America’s veterans, service members and their families are protected in writing.”

Amend the Manual of Procedure to the National Bylaws of the Veterans of Foreign Wars of the US, Article V, first sentence of Section 516 by striking out the title "Service Officer" and inserting the

title "Certified Veterans Advocate".

Amend the Manual of Procedure to the National Bylaws of the Veterans of Foreign Wars of the US, Article V, and Section 518(a) (11) by striking out title of "Service Officer" and inserting the title "Certified Veterans Advocate". First sentence strike out the title of "The Department Service Office" and inserting the title "The Department Certified Veterans Advocate."

Article VI – Districts

Section 1 after the first paragraph insert paragraph two as follows:

Districts shall hold at least two (2) regular meetings per year, one of which shall be for the purpose of promoting schools of instruction for Post officers. In addition, the Districts shall hold a District Convention not less than ten (10) days

nor more than seventy-five (75) days prior to the convening of the Department Convention for the purpose of electing officers and for the transaction of business.

The intent of this Bylaw change is to allow those Districts within heavy snow areas to avoid dangerous driving conditions during the winter months.

Article XIII Council of Administration

Section 1. The Budget & Finance Committee shall submit the proposed budget for the ensuing year to the Council of Administration at least seven (7) days prior to its July meeting. The budget must be adopted or altered and adopted by the Council of Administration at its July meeting following the Department Convention and after such adoption, cannot be changed, except by three fourths (3/4) vote of the Council of administration at a regular meeting at which two thirds (2/3) of its entire membership is present. No transfer of funds from any portion of the budget can be made except by the same procedure. No proposition involving either expenditure or receipt of funds by the Department can be acted upon by the Council of Administration before approval of the Budget & Finance Committee, except by a three fourths (3/4) vote of the Council of Administration members present at a regular or special meeting and all bills shall be approved, disapproved or referred without recommendation by the Budget & Finance Committee before the Council of Administration shall act on them.

Section 2. The Council of Administration shall hold not more than eight (8) nor less than four (4) regular meetings per year. The first to be called by the Department Commander immediately following the installation of Department Officers following the adjournment of the State Convention and the second to be called by the Department Commander prior to the last Sunday in July at such time and place as he may designate and the last meeting shall be held in the next convention city on the day prior to the official opening of that State Convention. All other meetings shall be held at the time and place designated by the Department Commander. The Adjutant shall give, or cause to be given, all members of the Council of Administration written notice, at least ten (10) days prior to each meeting, as to time and place. Special meetings may be called in accordance with the provisions of the National By-Laws and Manual of Procedure. In all cases of special meetings, notice of the Council of Administration members shall be sent as outlined above and shall specify the purpose of such special meeting.

Section 3. Any contract entered into by the Council of Administration, extending beyond the next Convention, shall be subject to ratification, modification or cancellation as regards to all phases of such contracts which extend beyond the Convention.

Insert "*Quartermaster, with the assistance of the*" after the word the in the first line of Article XIII, Section 1 to comply with the National By-Laws Article V, Section 518 (a)(4)(k).

Delete "*its July meeting*" from the third line of Article XIII, Section 1 and replace it with "*the first scheduled Council of Administration meeting*".

Delete "*July*" from the seventh line of Article XIII, Section 1 and replace it with "*first scheduled meeting*".

Delete "*its entire membership*" after the word of in Article XIII, Section 1, line 11 and insert "*the Council*" in its place.

Delete "*The first to be called*" from the

third line of Article XIII, Section 2 and replace it with "*Effective June 27, 2010 and each year thereafter the first Council meeting will be called.*"

Insert a **period (.)** after the word Convention on the seventh line of Article XIII, Section 2 and delete "*and the second to be called by the Department Commander prior to the last Sunday in July at such time and place as he may designate and*" capitalize the word "*The*" to begin the next sentence.

Article XIII Council of Administration shall read as follows:

Section 1. The *Quartermaster with the assistance of the* Budget & Finance Committee shall submit the proposed budget for the ensuing year to the Council of Administration at least seven (7) days prior to *the first scheduled Council of Administration meeting*.

The budget must be adopted or altered and adopted by the Council of Administration at its *first scheduled meeting* following the Department Convention and after such adoption, cannot be changed, except by three fourths (3/4) vote of the Council of Administration at a regular meeting at which two thirds (2/3) of *the Council* is present. No transfer of funds from any portion of the budget can be made except by the same procedure. No proposition involving either expenditure or receipt of funds by the Department can be acted upon by the Council of Administration before approval of the Budget & Finance Committee, except by a three fourths (3/4) vote of the Council of Administration members present at a regular or special meeting and all bills shall be approved, disapproved or referred without recommendation by the Budget & Finance Committee before the Council of Administration shall act on them.

Section 2. The Council of Administration shall hold not more than eight (8) nor less than four (4) regular meetings per year. *Effective June 27, 2010 and each year thereafter the first Council meeting will be called* by the Department Commander immediately following the installation of Department Officers following the adjournment of the State Convention. The last meeting shall be held in the next convention city on the day prior to the official opening of that State Convention. All other meetings shall be held at the time and place designated by the Department Commander. The Adjutant shall give, or cause to be given, all members of the Council of Administration written notice, at least ten (10) days prior to each meeting, as to time and place. Special meetings may be called in accordance with the provisions of the National By-Laws and Manual of Procedure. In all cases of special meetings, notice of the Council of Administration members shall be sent as outlined above and shall specify the purpose of such special meeting.

Section 3. Any contract entered into by the Council of Administration, extending beyond the next Convention, shall be subject to ratification, modification or cancellation as regards to all phases of such contracts which extend beyond the Convention.

DAY OF CHALLENGES

After switching from a fall schedule to a spring date, the Day of Challenges got underway again at the Michigan Tech Univ. Student Development Center in Houghton on March 20, 2010. Under the new leadership of Lt. Col. Jim Spence, MTU ARMY ROTC, and coordinated by Cadet Katy Hill, another flawless event was accomplished. Both are new to this project and they were quite impressed with the overall scope of the entire event and are to be commended for their efforts.

Once again, the Day of Challenges highlighted one of the VFW's primary goals of working with other groups and organizations to help further the development of our youth. For physical fitness, it tested students with push-ups, sit-ups and a 400-meter run. The skills event tested abilities in sports, teamwork and overall coordination and focus. Students ran a timed obstacle course and a leadership reaction course that tested the group's cohesiveness and mental agility. Each team was assigned a MTU ROTC cadet to encourage and guide the students through the events. The overall favorite of the students, by far, was in the diving pool, with the high board confidence jump being the most daring event. State Commander Dave Hutson declined the offer to take the 10 meter plunge, keeping intact the long standing tradition of the Dept. Reps. being outdone by a 5th grader.

Board of Managers and Veterans Homes

Comrades,

I would like to tell you about the Board of Managers and the two Veterans Homes in our great State of Michigan. First, the Board of Managers was created by Public Act 152 of 1895. The Board exercises certain regulatory and governance authority regarding admission and member affairs at Michigan's two State Veteran Homes. They also represent the interest of the veterans community in both advisory and advocacy roles. The Board Members are appointed by the Governor, with the advice and consent of the Senate, to serve six (6) year terms. Members of the Board of Managers consist of:

(2) Veterans of Foreign Wars – PSC Richard "Chic" LaFave from (Gwinn) and PSC Ernie Meyers, Sr. from (Charlotte)

(2) The American Legion – PSC Bill Coffey from (Lanes) and PSC Gary Veldman from (Muskegon)

(1) Disabled American Veterans – PSC Gerald Cool from Adrian

AMVETS – PSC Mary Wilseck from Livonia

Independent – David E. Hall from Rock (Upper Peninsula)

The Grand Rapids Home for Veterans is home for just over 700 residents.

- Domiciliary (ambulatory) – 140 beds available, 64% filled at present.
- Nursing Care – 618 beds available, 94% filled at present.

* Average assigned nursing beds 610*

The D.J. Jacobetti Home for Veterans, located in Marquette, houses 240 residents.

- Domiciliary (ambulatory) – 58 beds available, 15.52% filled at present.
- Nursing Care – 182 beds available, 98.90% filled at present.

The entire Home should be completely renovated by fiscal year end 2010

Special Note: The Board of Managers is being apprised of the need to increase the "Special Needs" area at both homes. The

nursing care is on the rise at both locations. The area around the courtyard at the Grand Rapids Home could be the site for a new wing to accommodate the "Special Needs." Comrades, you may be called on to help make this project a reality.

In Fiscal Year 2010, the Department of Management and Budget (DMB), was directed to cut \$1.1 million from the two homes. This directive came directly from our State Legislature and was approved by the Governor. Further, we have been directed to forecast a three (3) year budget through Fiscal Year 2012 with a 10% reduction. This comrades, cuts the two homes' budgets by 12% over the next four years. This is totally unacceptable. We need you to contact your State Senators and State Representatives to solidify the budgets of our State Veterans Homes so that we do not infringe on the health care needs of our Veterans. Thank you for your support over this past year and your continued support to assist the veterans at the Grand Rapids and the D.J. Jacobetti homes.

Finally, the Veterans of Foreign Wars and its Ladies Auxiliary leads the charge in volunteer organizations when it comes to volunteer hours and donations. Thank you, from the two Home Administrators and the Board of Managers.
