### Past Commander-in-Chief



Edward S. Banas, Sr., was elected Commander-in-Chief of the Veterans of Foreign Wars on August 29, 2003 at the 104th National Convention, held in San Antonio, Texas. He is only the second member from Connecticut to be elected to this position.

Ed served in the Army from 1965-68. In Vietnam, he was assigned to the 18th MP Bde. He was awarded the Vietnam Campaign Medal, Vietnam Service Medal, National Defense Medal and the Army Good Conduct Medal.

In 1967, while still in the military, Ed joined VFW Post 10004 in Jewett City, Connecticut. He served in a variety of positions at the Post level, including Post Commander. At the District level, Ed earned the honor of All-American District

Commander. He served as Department Commander of Connecticut in 1993-94.

On the National level, Ed has served on several committees including Safety, Bylaws, Budget & Finance, and as Chairman for both the Americanism and Legislative Committees. He served a twoyear term, 1994-1996, as a member of the National Council of Administration representing the Departments of Massachusetts and Connecticut. In 1998-1999, he served as the Eastern States Conference Chairman.

Ed put his military police experience to good use when he became a member of the Norwich Police Department in 1968. He served with the department for more than 10 years. During this time, he was a member of several law enforcement associations, including Patrolman's Benevolent Association, New London County Detective Association, Connecticut Narcotic Officers Association and the International Narcotic Officers Association.

He attended Northeastern University for the Study of Constitutional Law for Police, Police Organizations and Management. He also attended the Department of the Treasury-Bureau of Alcohol, Tobacco & Firearms School for Criminal Investigations.

Ed is a member of The American Legion, the Voluntown, Connecticut Historical Society and a Life Member of VFW Post 10004. He has five children and resides with his wife, Sandra, in Niantic.

We are fast approaching the end of the calendar year with Thanksgiving and Christmas just around the corner and winter setting in. Remember those in the hospital and the Michigan homes this year and send sweaters, gloves, scarves and winter coats (both male and female) to Grand

(both male and female) to Grand Rapids and Marquette.

If you have not purchased new podium editions of the National Bylaws, Manual of Procedure and Ritual – you need to order them now. There are new changes that you will need to know about.

As many of you know, we took a \$30,000.00 reduction in our guarantee program this year, mainly due to the fact that contributions are not going into National. Please remember that National does not make a dime on the member donation requests through the calendars, labels and other items sent to you through the mail. The net revenue comes back to the Department, which is used for the



programs in which we participate. We need your assistance.

We have at this writing four Posts that are reapplying for their nonprofit status with the IRS. Your Post must file the 990, 990EZ or the 990N to keep your nonprofit status. We also have Posts struggling with late 941 quarterly reports and 940 annual FUTA reports. The trustees of the Post need to make sure that these are filed and subsequently report back to the Post that all tax forms have been completed and mailed.

I hope everyone had a Happy Thanksgiving and we wish you a Merry Christmas and a Happy New Year.

# Department Service Officer SUCCESS STORY

Every day, we get phone calls from all over Michigan and for that matter around the country regarding multiple topics on multiple issues. In March of 2010 we received such a call from a former Marine who served in Vietnam. He indicated that he had grave concerns about his squad leader that led him into battle on several occasions. They met at Khe-Sanh in 1968; surrounded by enemy forces, subjected to constant artillery, rockets and mortars for 90 days. They experienced a lot together, that only combat Marines can appreciate. Over the years of living life's battles, they lost contact with one another.

In 1994, the caller was reading a *Veterans Magazine* and spotted his old squad leader's name. After numerous attempts to locate the squad leader, he finally made contact. It was like old times, less the bullets streaking over their heads. Jabbering away like a couple of school kids, they got caught up with each other's lives and reminisced, laughed and cried about their Vietnam service. It was like they never parted!

Later in the late 1990s, our caller was having some personal problems, dealing with and getting a lot of grief from the Department of Veterans Affairs. As a leader, his squad leader did what he always did best and that was to help him "keep it together" in times of uncertainty.

Through many conversations they both had with one another over the years, it became very apparent that the leader who led him into battle on so many occasions was having the very same issues with the VA that our caller had. Unfortunately, for the Squad Leader, his physical health had deteriorated rapidly over the years and this prevented him from actively persuading any corrective action with the Department of Veterans Affairs. Now, the veteran who called us with the concern for his fellow Marine wants to be there for his squad leader as he was for him back in Vietnam and in the 90s.

We secured the indentifying information from the caller and our Service Officer contacted the veteran. Over the past several months we have had lengthy conversations with the veteran on several occasions. When all is said and done, we couldn't believe what we were hearing from this former Marine and Squad Leader.

First and foremost, we made a determination that the VA did not evaluate the veteran properly. Secondly, due to his health, our "squad leader" was pretty much abandoned by his family and lived up in the mountains. He pretty much kept to himself – didn't really trust anyone.

The Service Officer asked the VA to transfer the veteran's claims folder to the Detroit Regional Office so he could do a thorough review. After the review, we found out that the veteran was currently rated at a combined 60% evaluation. This confirmed our previous assumption that the veteran was not rated properly.

We asked that the veteran be re-evaluated for his service-connected conditions. In addition, we asked that

Merry Christmas and Happy Hanukkah; may God bless you.


### STATE SERVICE OFFICER

### **Advocating for Others**

Since April of 2010, the Michigan Veterans Coalition (MVC) has been providing veterans service throughout the State of Michigan. It has been a very rewarding experience and we continue to make changes as needed. Since

January, the MVC has been working diligently to gather and put together grant applications for FY 2011-2012. On Wednesday, September 21, 2011 the following grants were awarded:

Grant (1A) not to exceed \$1,000,000 to provide veteran advice, advocacy and assistance to veterans throughout the State with a special emphasis on the Upper Peninsula and the D. J. Jacobetti Home for Veterans, grant (1B) not to exceed \$1,000,000 to provide veteran advice, advocacy and assistance to veterans throughout the State with a special emphasis on the Grand Rapids Home for Veterans, grant (2A) not to exceed \$600,000 to provide veteran advice, advocacy and assistance to veterans in the eastern portion of Michigan's Lower Peninsula and grant (2B) not to exceed \$300,000 to provide veteran advice, advocacy and assistance to veterans in the western portion of Michigan's Lower Peninsula, all have been awarded to the Michigan Veterans Coalition consisting of The American Legion, Department of Michigan; the Disabled American Veterans, Department of Michigan; the



Marine Corps League, Department of Michigan; the Military Order of the Purple Heart, Department of Michigan and the Veterans of Foreign Wars, Department of Michigan. The Veterans of Foreign Wars, Department of Michigan serves as manager and lead organization of the Michigan Veterans Coalition.

This is great news for the MVC! However, this news comes with an enormous responsibility to our overall veteran community here in the State of Michigan.

Our promise to the State of Michigan is to:

- Establish, reinforce and enhance a public presence throughout the State of Michigan.
- Provide access to initial representation for Michigan veterans and families.
- Provide direct service to the members of Michigan's State Veteran Homes.
- Refer veterans and families to the appropriate local, state, federal and non-governmental agencies for benefits, entitlements and support.
- Provide support for veterans seeking appeals or redress from initial decisions by the U.S. Department of Veterans Affairs.

he be considered service-connected for several previously denied claims that are under the herbicides exposure act.

When the veteran came to us, he was receiving a small monthly award of compensation. Today, he is rated at three separate 100% ratings, two separate 60% evaluations. This equates to an R2 award for Special Monthly Compensations.

He receives a monthly compensation award of \$7,650. The veteran was paid a retroactive check in the amount of \$539,754.

"Semper Fidelis" (the Marine Corps motto) means "Always Faithful". Faithful to God, Country and Corps. To that end, the above story epitomizes that a brotherhood that was made in combat has been sealed for life. The motto's meaning "Always Faithful" was not just a catch phrase, but also a living testament by these two Marines who continue to fight the good fight.

By the way, Happy 236th Birthday to the Marine Corps family.

- Put an emphasis on contacting and serving severely wounded post-9/11 veterans.
- Finally, establish a presence at public universities and colleges, as well as community colleges.

As one might guess, this is a pretty aggressive agenda, but we feel the MVC is up to the task at hand and will succeed!

In addition, based on this agenda we will be required to shift resources to other localities that are under served or are well below the national average. This is still a work in progress and will be for the foreseeable future.

On another note, there have been some recent changes in our national policy regarding Post Service Officers. The following are those changes that each and every Post Commander should ensure that the Post Service Officers abide by.

The primary task of a Post Service Officer (PSO) is to provide information concerning Federal, state and local benefits for veterans, their families and survivors. In this capacity, PSO's may provide applications or other forms to claimants; when requested, the PSO may help a claimant complete a form by acting as a recorder.

All material submitted in relationship to a claim must be either forwarded to the **E-Mail: vfwmiadvocates@gmail.com** 

Department Service Office or returned to the claimant. Under no circumstances should the PSO retain any personally identifiable information concerning the claimant or the claimants' family.

When acting as a recorder, the PSO is simply transcribing information provided by the claimant. At no time should the PSO make suggestions on how to frame information to make it appear more favorable or less harmful to the claimant.

Under no circumstances should a PSO counsel a claimant on their individual claim. While a PSO provides information concerning various government benefit programs, he/she should not offer any guidance or opinion as to the individual claim itself. General statements about the types of evidence necessary to support a claim can be described; however, a PSO must not discuss the nature or merits of any particular claim.

### Liimatta named U.P. Veteran of the Year

Chassell Post member to be honored at U.P. State Fair By Kelly Fosness, DMG writer (kfosness@mininggazette.com) - The Daily Mining Gazette



August 16, 2011, CHASSELL – Rev. Elmer Liimatta of VFW Post 6507 in Chassell has been selected as the 2011 Upper Peninsula Veteran of the Year.

"It's pretty humbling," Liimatta said. "There's 35,000 other veterans (in the Upper Peninsula) that probably deserve it more."

Liimatta, who is National Chaplain of the Veterans of Foreign Wars, will be honored during an 11 a.m. award ceremony Thursday at the U.P. State Fair in Escanaba. In addition to receiving a new cap and jacket, Liimatta will be presented with a plaque from Gov. Rick Snyder.

"It's a pretty prestigious award," U.P. Veteran of the Year Committee Adjutant William LaMarch said, noting he earned the award two years ago. "You're being judged by veterans and leaders of the veteran community. They look at the good that you do for society."

Liimatta said there are nine veterans groups in the U.P. and they include: Veterans of Foreign Wars, American Legion, Disabled American Veterans, Purple Heart, Vietnam Veterans, AMVETS, Marine Corps League, Forgotten Eagles and Patriot Guard Riders. The selection committee consisted of members from those organizations.

"I've got good friends," Liimatta said. "That's why I got elected."

Liimatta served in the U.S. Army from 1952-54 and received several awards. He was awarded the Korean Service Ribbon with one Bronze Service Star, the National Defense Service Medal, the Republic of Korea Presidential Citation and a United Nations service medal.

Liimatta earned his doctorate of ministry from Ecumenical Theological Seminary in 1994. He was a pastor for 53 years, police chaplain for 30 years and board member/ teacher at Inter-Lutheran Seminary for 40 years, before retiring in 1994.

In 2000, Liimatta served as Post Chaplain and District 15 Chaplain. He was Western Michigan VFW Chaplain in 2007, State Chaplain from 2007 to 2011 and National Chaplain from 2010 to 2011.

Earning U.P. Veteran of the Year, Liimatta said, opens doors to talk and be a veterans' advocate.

"Many times the veterans and families that we've helped, they're the last ones to recognize or know that there's programs available," he said. "For instance, in Michigan, we have a \$50 million veterans' trust fund and any veteran can apply for emergency funds."

Liimatta said there are eight issues they're working on currently through the VFW. They are: VA health care, VA benefits and compensation, seamless transition, military quality of life, education and employment, military affairs, defense and homeland security, and POW/MIA.

"We've got about 600 resolutions right now that we're trying to work on," he said. "I'm on a resolutions committee – we're encouraging keeping the draft and so on. We're not only looking after our veterans, but we're trying to look after our nation."

Liimatta resides in Chassell with his wife, Ruth. He serves 20 churches, makes regular visits with the elderly and veterans, and continues a favorite pastime - working on old cars. Currently, he's restoring a 1928 Model A Ford Roadster convertible pickup and a 1934 Ford Roadster.

### 10 for 10: We Won't **Stand for Broken Promises**

Recently, when Congress voted to raise the nation's debt ceiling, they specifically targeted National security to absorb many of the cuts, indicating that Department of Defense personnel programs and VA benefits would not be spared.

Leaders in Congress have already discussed cutting or eliminating 10 benefits proposed plans that would leave America's affecting military members, veterans and their families in recent months, and the VFW believes that these toxic proposals will once again gain momentum as Congress looks for ways to tighten its belt.

America's all-volunteer military has shouldered a multi-theater war all by themselves for almost 10 years. They did so without question, and often with tremendous sacrifice to themselves and their families.

Americans understand the scope of the national debt crisis; a crisis that could have serious repercussions on a military at war and a veterans' population that has already sacrificed much for the nation. However, instead of debating and enacting meaningful fiscal reforms, some in Congress have military and her veterans to shoulder more of the national debt.

This "10 for 10" plan – to cut 10 specific benefits to pay for 10 years of war - is a breach of faith with America's military and veteran families, and we are calling upon you, our members, to fight it.

"Our military and veterans have earned each of the 10 benefits Congress is proposing to cut. Our nation broke a similar promise to her World War I veterans. It took the

District and the state what you are doing, plus it gives yourself an opening for advice and questions from other Posts and persons concerned. It's all about communication.

the box with all your entries. Separate them with a number, letter, some spaces or slashes. This will save you and us time with stop and go entries. To all Posts with more than one member gathering information, combine them together to avoid the stop and go and duplication of events.

VFW to lead thousands of them in a march on Washington until Congress made the responsible choice to support them. The VFW wouldn't stand for broken promises then and we won't stand for it now."

The 10 ways Congress is targeting military and veterans' benefits during today's difficult fiscal times are to:

- •Increase healthcare premiums for military retirees on TRICARE
- •Increase pharmaceutical fees for troops, families and retirees
- •Eliminate presumptive serviceconnected conditions for disabled and ill veterans
- •Lock out or increase fees for Department of Veterans Affairs Priority Groups 7

and 8 veterans

- •Reduce cost-of-living allowances
- •Freeze military pay
- •End government subsidies to military commissaries
- •Eliminate Department of Defense elementary schools stateside
- •Eliminate the 20-year military retirement plan
- •Eliminate DoD tuition reimbursement programs for service members

While Congress publicly debated raising the nation's debt ceiling, the VFW was concerned that many of the proposed cuts were being discussed behind closed doors. The VFW has the same concerns over the new bipartisan "Gang of 12" Super

Congress tasked to develop the nation's debt reduction plan. The VFW recognizes that the nation must make difficult fiscal decisions, but the programs and benefits provided to veterans and military families were prepaid in full through their honorable service and sacrifice.

"Unlike other government-funded entitlement programs, veterans earned their benefits by making a National commitment that 99 percent of other Americans are simply unwilling to make. To ask these same men and women to sacrifice more is simply unconscionable."

The VFW also believes that cutting the 10 benefits could have tremendous impact on military recruiting and readiness,

and threaten the future viability of the all-volunteer force. Healthcare, education, a retirement system and family programs are critical factors in retaining talented personnel in a low-paying and extremely dangerous profession.

While the debate over fiscal responsibility continues to unfold in Washington, the VFW will work to ensure that military and veterans' benefits remain intact.

In the coming weeks, the VFW will continue to put pressure on Congress to ensure proposed fiscal reforms do not negatively affect troops, veterans or their families.

# Stars & Stripes OpEd: VFW Blasts Proposed Changes to Retirement, Tricare

Having just returned from a Defense Department-sponsored trip into Afghanistan, I can report that troop morale is as good as anyone can expect from veteran warriors who have spent more time in Afghanistan or Iraq over the past decade than they have at home. But their Number 1 concern is about proposals emanating from the White House and Congress that threaten to eliminate, reduce or tax whatever slim financial benefits

there are to joining – much less staying in – the military.

The 100,000 American troops stationed in Afghanistan and more than 2 million elsewhere are right to be worried.

President Barack Obama wants to assemble a commission to examine the military retirement system, which currently provides a modest income immediately after someone donates 20 or more years of their youth to the nation. He would also impose an initial \$200 enrollment fee on military retirees age 65 and older who use Tricare for Life as their insurance supplemental to Medicare Part B.

Senate Armed Services Committee Chairman Carl Levin, D-Mich., would expand the scope of the president's retirement commission to look at all pay and allowances, and possibly remove the non-taxed status of housing, separate rations and clothing allowances, as well as combat pay.

The committee's ranking Republican, Sen.

# First Amendment Will Prevail at Houston VA National Cemetery

Cemetery will not interfere with prayers, religious expression during burial services.

October 21, 2011 – The Veterans of Foreign Wars today declared victory in a Federal Lawsuit (Rainey v VA) filed over allegations of religious hostility and unlawful censorship by the VA and its director of the Houston National Cemetery.

Federal District Judge Lynn N. Hughes signed a consent decree ordering the U.S. Department of Veteran Affairs (VA) to lift the ban on prayer and the word "God" at national cemeteries, to revoke national policies hostile to religion, and to reopen the Chapel which identity was previously changed to "meeting facility" at the Houston National Cemetery.

Texas-based Liberty Institute filed suit on behalf of the VFW over allegations of religious hostility and unlawful censorship by the VA and its director of the Houston National Cemetery. Officials told the VFW they could not have prayer during the burial services of veterans unless the family requested it specifically in writing and submitted the prayer to VA officials for pre-approval.

"The VFW is grateful that the

government has restored the basic tenets recognized in the U.S. Constitution – which guarantees fundamental rights of religious expression and freedom of speech – to patriotic Americans who sacrifice everything to defend it. This is indeed a victory." said VFW National Commander Richard DeNoyer.

"We are thankful that after almost five months of litigation, the government is finally doing the right thing by entering into a consent decree and ending religious hostility at the Houston National Cemetery," said Jeff Mateer, general counsel for Liberty Institute. "I am glad to see the VA overturn these policies, which will allow us to perform the entire VFW burial ritual," said Inge Conley, Commander of VFW District 4 in Houston and the VFW entity that initiated the lawsuit. "We should be able to include prayers, mentions of God, and the phrase, 'May God grant you, grace, mercy and peace,' to grieving families laying American soldiers to rest."

John McCain of Arizona, would prohibit new retirees and possibly all retirees from enrolling in Tricare Prime, which has the least out-ofpocket expenses.

The troops and commanders I spoke with in Afghanistan are of one voice against the proposals to change their pay and allowances, the existing military retirement system and the overall Tricare health program. They see it as a breach of faith and a complete lack of support, understanding and appreciation for what they do daily for the rest of America. They also cannot comprehend why anyone would even propose such measures while our nation is still engaged in two wars.

I absolutely agree, and will use my current position as the national commander of the nation's oldest and largest combat veterans organization to help defeat any and all measures that would have those who sacrifice the most to sacrifice more.

### **VA Encourages Veterans Who Suspect They've** Sustained a Brain Injury to Get Screened

- 1. The flag should be folded in its customary manner. (See VFW Ritual Book)
- 2. It is important that the fire be sizeable and of sufficient intensity to ensure complete burning of the flag.
- 3. Place the flag on the fire.
- 4. The individual (s) can come to attention, salute the flag, recite the

period of silent reflection.

- 5. After the flag is completely consumed, the fire should be safely extinguished and the ashes buried.
- 6. Please make sure you are conforming to local/state fire codes or ordinances.

The resolution conforms to the intent and letter of the U.S Code and the Federal Flag Code. This is the only acceptable way of handling U.S. flags that are no longer fit to be flown. No other handling of a retired flag is considered acceptable.





### VFW Report from Afghanistan

### Threats to military pay and benefits impacting troop morale

The National Commander of America's oldest and largest major combat veterans' organization is returning from Afghanistan today extremely concerned that White House and congressional proposals to eliminate or reduce military pay and benefits is impacting the morale of 190,000 deployed American troops.

"The troops are of one voice against proposals to change their pay and allowances, the existing military retirement system, and the overall TRICARE health program," said Richard L. DeNoyer, the national commander of the Veterans of Foreign Wars of the U.S., who arrived in Afghanistan on Monday as part of a Defense Department-sponsored trip that also included the leadership of The American Legion, AMVETS, and the Military Officers Association of America.

a retired Marine and Vietnam combat veteran from Afghanis, and said Afghan President Hamid Karzai support to protect the current military retirement and Middleton, Mass. "They also cannot comprehend why is very supportive and appreciative of America's anyone would even propose such measures while our commitment to his country. nation is still engaged in two wars."

The VFW national commander promised everyone he met that the VFW will fight any proposal that eliminates or reduces military and veterans' programs just to balance the federal deficit. He also asked the troops to help spread the VFW's message to their families and friends, because "it is critical that our voices not be lost in the ongoing budget debate," he said.

DeNoyer met on several occasions in Kabul with Marine Corps Gen. John R. Allen, who commands all coalition forces, as well as with Army Maj. Gen. Daniel B. Allyn, the 1st Cavalry Division commander, and with Special Forces' commanders who are training Afghan troops.

Based on briefings and meetings, the VFW national commander reports that Afghanistan is difficult, it is complicated, and any definition of success involves "They see it as a breach of faith and a complete lack the Afghan government assuming total control over of support, understanding and appreciation for what it their own country. Yet he calls the Afghan army is they do daily for the rest of America," said DeNoyer, a good fighting force that is respected by fellow

"Everyone I spoke to believes in the mission and are

proud of their accomplishments," said DeNoyer, who added that future successes could be complicated by the announced troop reduction to below 70,000 next fall. Yet despite the threat to their military pay and benefits, the VFW national commander said troop morale is as good as one can expect from veteran warriors who have spent more time in Afghanistan or Iraq over the past decade than they have at home.

"I am so proud of their continued motivation, dedication, and selfless service not only to America but for Afghanistan as well," he said. "That's why it is so important for both military and veteran communities to join together with one voice to defeat these proposals. Morale wins wars."

In continuing his call to action, the VFW national commander is asking his 2 million VFW and Auxiliary members, along with their friends and families, to contact their congressional members today to urge their pay and allowance system, all TRICARE programs for military families and retirees, and all VA healthcare programs for wounded, ill and injured veterans.





### **VFW Supports Montford Point Marines**

Senate urged to pass Congressional Gold Medal legislation

The Veterans of Foreign Wars of the U.S. is urging the Senate to pass S. 1527 to authorize the award of the Congressional Gold Medal to the Montford Point Marines of World War II. Its companion bill passed unanimously in the House earlier this week.

"The Montford Point Marines paved the way for future generations of African Americans to proudly call themselves United States Marines," said VFW National Commander Richard L. DeNoyer, a retired Marine and Vietnam combat veteran from Middleton, Mass. "And just like the Army's Buffalo Soldiers and the Air Force's Tuskegee Airmen, they must be properly recognized for their service, their sacrifice, and most especially for their perseverance to overcome the racial challenges of the time to help our nation fight and win World War II."

The House bill, H.R. 2447, was introduced in July by Rep. Corrine Brown (D-Fla.), and had garnered 308 bipartisan cosponsors before

Tuesday's 422-0 vote. S. 1527 was introduced in September by Sen. Kay Hagan (D-N.C.) and currently has 27 bipartisan cosponsors, but the bill was referred for action to the Senate Committee on Banking, Housing, and Urban Affairs. It has yet to exit the committee. DeNoyer wants S. 1527 brought to a vote when the Senate reconvenes next week.

The history of Montford Point is rooted in pride and prejudice, according to the Montfort Point Marines Association. President Franklin D. Roosevelt opened up the military services to recruit African Americans in 1941, but it still took a 1942 presidential directive to give them the opportunity to be recruited into the Marine Corps. Instead of going to established training facilities on Parris Island, S.C., or in San Diego, Calif., a segregated boot camp called Montford Point was created next to Camp Lejeune, N.C., where 20,000 African American Marines would eventually be trained between 1942 and 1949.

In a July 30 speech in Atlanta before the Montford Point Marines Association, Marine Corps Commandant Gen. James F. Amos said their story and struggle for equality and acceptance in the Corps did not end when they left Montford Point; rather, it had just begun, because they were not allowed to become infantrymen or to serve in other mainstream military occupational specialties.

"It's ironic, but the Marines from Montford Point who saw the most action in World War II were those assigned to segregated ammunition and depot companies," said Amos, who is a strong advocate of the Congressional Gold Medal legislation. "To resupply the front lines, these men often had to fight their way to the front, and then carry back wounded white Marines to the rear for medical care. [They] demonstrated their mettle during vicious and bloody fighting in places like Saipan and Okinawa."

Their courage under fire and fidelity to fellow Marines, regardless of skin color, began to erode the cruel and false generational stereotype within the Corps that blacks could not, and would not, fight in the face of danger. This led Gen. Alexander Vandegrift, then Commandant of the Marine Corps, who had observed the courage of black Marines in hand-to-hand combat on Saipan, to say "The experiment with the Negro Marines is over. They are Marines...period!"

As the Marine Corps prepares for its 236th birthday on Nov. 10, the VFW national commander said there could be no more fitting tribute than for the Senate to announce beforehand that they, too, agree that the Montford Point Marines should be awarded the Congressional Gold Medal.

"This is about properly honoring a group of patriotic Americans who battled an enemy abroad and racism at home," said DeNoyer, who is now asking his two million VFW and Auxiliary members to urge their U.S. senators to pass S. 1527. "This recognition is long overdue, and with the VFW's support, we hope it soon becomes reality."

# VFW Calls White House Proposals a 'Breach of Faith'

'The proposals are all about money, not about people'

WASHINGTON – The national commander of the nation's oldest and largest major combat veterans' organization is sounding the alarm over President Obama's deficit reduction plan because some proposals are clearly designed to balance the budget on the backs of current and future military service members, retirees and their families.

"The proposals are all about money, not about people," said Richard L. DeNoyer, who was elected Sept. 1 as the Commander-in-Chief of the 2 million-member Veterans of Foreign Wars of the U.S. and its Auxiliaries.

Released by the White House today was a summary of the president's plan that impacts military retirees as well as those still serving and their families. The plan would impose an initial \$200 annual fee on TRICARE-for-Life recipients, increase TRICARE pharmacy copayments for military dependents and retirees of all ages, and create a commission to examine overhauling the existing military retirement system.

"Our nation's financial situation cannot be solved by breaking faith with those who singlehandedly fight our nations wars – be it today or tomorrow," said DeNoyer, a retired Marine and Vietnam combat veteran from Middleton, Mass. "You cannot pass along our nation's security to future generations just for short-term financial gain. That is an extremely dangerous assumption, and totally disregards the fact that there is an inherent cost that our nation should be more than willing to pay in exchange for asking someone to join, much less donate 20 or more years of their youth to defend

our country."

The VFW national commander said he was surprised by the TRICARE-for-Life fee because "the president has repeatedly said he would not balance the budget on the backs of veterans," said DeNoyer. "We were against TRICARE fee increases when the Defense Department first proposed it for working-age retirees in February, and the VFW is definitely against imposing fees on those 65 and older who reside on fixed incomes and who are already forced to make Medicare Part B payments. Imposing a \$200 annual fee with unknown future increases on this age group is an extreme breach of faith."

DeNoyer said the VFW has also been strongly against changing the military retirement system ever since the Pentagon first decided to float as a trial balloon the recommendation made by the Defense Business Board, a civilian advisory group whose purpose is to bring corporate "best practices" to a military institution it has nothing in common with.

"It disregards decades of upfront service and sacrifice that's required of the less than 10 percent of the force who choose to make the military a career," he said. "It ignores the fact that when the economy rebounds the military services won't be fat with record recruiting and retention rates. Plus it fails to mention that any potential savings won't be realized for at least two decades, while our military could still be engaged in a multi-front war on terrorism."

Those in uniform also pushed back. An online survey published Aug. 29 in all four service issues of The Military Times showed that 88 percent of the force clearly disliked changing the existing

retirement system. A front-page headline in the Sept. 5 editions screamed "Don't mess with our retirement!"

DOD leadership has since been working hard to calm their fears, to include saying the proposal had not yet been presented formally, and that any such change would only impact future recruits, not those currently serving or those already retired. Military retirees and those in uniform can separate rhetoric from reality, however, especially given today's White House announcement.

"Changing the retirement system will provide an incentive to separate after 10 years, which will decimate the ranks of mid-career officers and noncommissioned officers when they are in their prime working age," said DeNoyer. "It will make potential recruits think twice about joining, because they can receive a 401(k)-type retirement plan anywhere and earn it much more safely. And it could mean future military leaders get promoted not because they are the best, but because no one else is around."

The VFW national commander believes demands for the nation's military to sacrifice more is a perfect recipe for another hollow force, and could threaten the continued success of the All Volunteer Force.

"Instead of consistently trying to bring the military closer to parity with civilian or other federal employee plans, perhaps what we most want to hear is how America is going to bridge the shared sacrifice gap with the less than 1 percent of the population who are in the fight – then we can talk about parity," said DeNoyer, who wants VFW representation on the retirement commission.

Korean War MIA Identified: The Defense POW/Missing Personnel Office announced the identification of remains belong to Army Cpl. Eugene M. Morelli, 21, of Santa Ysabel, CA In February 1951, Morelli and elements of the 2nd Infantry Division were forced to withdraw during the Battle for Hoengsong in South Korea. Morelli was captured but died in captivity due to malnutrition.

**Eleven MIAs Return Home:** The Defense POW/Missing Personnel Office announced the identification of remains belonging to 11 airmen, one from Vietnam and 10 from World War II. Returned are:

- \* Army Air Forces 2nd Lts. Robert R. Bishop, 24, of Joliet, Ill., Thomas Digman, Jr., 24, of Pittsburgh, Donald W. Hess, 28, of Sioux City, Iowa, and Arthur W. Luce, 24, of Fort Bragg, Calif.; Staff Sgts. Joseph J. Karaso, 21, of Philadelphia, and Ralph L. McDonald, 22, of East Point, Ga.; and Sgts. John P. Bonnassiolle, 20, of Oakland, Calif., James T. Blong, 19, of Port Washington, Wis., Michael A. Chiodo, 22, of Cleveland, and John J. Harringer, Jr., 20, of South Bend, Ind. On April 29, 1944, their B-24J Liberator crashed near the town of East Meitze, Germany, while on a bombing mission of Berlin.
- \* Air Force Col. Gilbert S. Palmer Jr., 37, of Upper Darby, Pa. On Feb. 27, 1968, Palmer and another crewmember were on a photo-reconnaissance mission of enemy targets in Quang Binh, North Vietnam, when their RF-4C aircraft crashed in an unknown location that eventually turned out to be across the border in Laos.

Two MIAs Return Home: The Defense POW/Missing Personnel Office announced the identification of remains belonging to an Army soldier missing since the Korean War, and an Air Force pilot missing from the Vietnam War.

- \* In late November 1950, Army PFC Henry L. Gustafson, 18, of Cook, Ill., and his 31st Regimental Combat Team were forced to withdraw after coming under attack by communist forces near the Chosin Reservoir. After the 1953 armistice, a surviving POW confirmed that Gustafson had been captured but died from lack of medical care shortly afterwards.
- \* On Feb. 8, 1969, Air Force Capt. Thomas E. Clark, 29, of Emporium, Pa., was attacking an anti-aircraft artillery position in Savannakhet Province, Laos, when his F-100D Super Sabre aircraft was struck by enemy fire and crashed. No parachute was seen, and immediate search and rescue missions were unable to locate the crash site or the pilot.

Korean War MIA Identified: The Defense POW/Missing Personnel Office announced the identification of remains belonging to Army Pfc. Aaron Pearce, 23, of Johnston, N.C. In late April of 1950, Pearce and the 25th Infantry Division were advancing north when Chinese forces attacked and pushed them back to Seoul. Pearce and many others were reported as missing in action as a result of the engagement. In 1952, military clothing and human remains were recovered near the area but the Army at the time was unable to identify Pearce, who would eventually be buried as an "unknown" at the National Cemetery of the Pacific in Honolulu.

Four Korea, Vietnam MIAs Recovered: The Defense POW/ Missing Personnel Office announced

the identification of remains of four soldiers lost during the Korean and Vietnam Wars. They are:

- \* Army Cpl. Edward M. Pedregon of El Paso, Texas. In late November 1950, Pedregon and his Heavy Mortar Company of the 31st Regimental Combat Team were overrun by Chinese forces near the Chosin Reservoir in North Korea. Pedregon was reported missing in action on Nov. 30, 1950.
- \* Army Master Sgt. Charles V. Newton of Canadian, Texas; Sgt. 1st Class Douglas E. Dahill of Lima, Ohio; and Sgt. 1st Class Charles F. Prevedel of St. Louis, Mo.. On April 17, 1969, the men and three Vietnamese soldiers were on a long-range reconnaissance patrol when they were ambushed near the Laotian border. Search and rescue teams reached the site the next day but over the next week found no signs of the men.

**Five MIAs Return Home:** The Defense POW/Missing Personnel Office announced the identification of remains belonging to five American servicemen – one each from World War II and Korea, and three from Vietnam. Returned are:

- \* Army Air Forces Capt. Jennings H. Mease, 36, of Greenville, S.C. On April 24, 1943, Mease and four other airmen were flying over the Himalayan Mountains from China to their home base in India. After losing radio communications following takeoff, their C-87 Liberator was not heard from again.
- \* Army Cpl. Freeman Lindsey, 20, of Rockport, Ind. On Nov. 29, 1950, Lindsey would be reported missing after his 31st Regimental Combat Team came under attack near the Chosin Reservoir in North Korea. After the 1953 armistice, surviving POWs said

- Lindsey had been captured but later died of malnutrition while in captivity.
- \* Army Specialist 4 Marvin F. Phillips, 20, of Palmer, Tenn. On Sept. 26, 1966, Phillips and three others crashed off the coast of South Vietnam when their UH-1B Huey helicopter was struck by small arms fire. One crewmember survived and the remains of a second were recovered; Phillips and the fourth were not found.
- \* Air Force Maj. Bruce E. Lawrence, 25, of Easton Pa. On July 5, 1968, Lawrence and Maj. Edward D. Silver were flying in an F-4C Phantom II aircraft on a night armed-reconnaissance mission of enemy targets in Quang Binh Province, North Vietnam. Anti-aircraft fire struck the aircraft before it crashed. No parachutes were observed.
- \* Army Sgt. 1st Class William T. Brown, 24, of Lahabra, Calif. On Nov. 3, 1969, Brown and two other Americans, plus six Vietnamese soldiers, were part of a Special Forces reconnaissance patrol that was ambushed near the Vietnam-Laos border. Search and rescue teams found equipment but no sign of the three missing American soldiers.

Korean War MIA Identified: The Defense POW/Missing Personnel Office announced the identification of remains belonging to Army Sgt. Lee D. Henry, Jr., 22, of Tyler, Texas. In August 1950, Henry died and was buried, but available documentation didn't identify the individual or indicate where the remains were originally found. He was subsequently exhumed and reburied as an unknown in the National Memorial Cemetery of the Pacific in Honolulu. In 2010, scientists from the Joint POW/MIA Accounting Command concluded they had evidence to support his identification.

Two Vietnam MIAs Identified: The

Defense POW/MIA Office announced the identification of remains belonging to an Air Force fighter pilot and an Army Special Forces soldiers who had been missing in action for more than four decades.

- \* Air Force Maj. Thomas E. Reitmann, 34, of Red Wing, Minn., was assigned to the 334th Tactical Fighter Squadron at Takhli AB, Thailand, when on Dec 1, 1965; he flew an Operation Rolling Thunder strike mission against a railroad bridge northeast of Hanoi. When his flight of four F-105D Thunderchiefs approached the target area, they encountered extremely heavy anti-aircraft artillery. Reitmann's aircraft took a direct and crashed.
- \* Army Master Sgt. Ralph J. Reno, 36, of Chicago, took off from Kham Duc, South Vietnam, on July 3, 1966, aboard an H-34 helicopter with three soldiers from 5th Special Forces Group, three Vietnamese aircrew and nine Vietnamese passengers. The aircraft crashed in Quang Nam Province in steep mountainous terrain and dense foliage after they encountered severe air turbulence.

WWII and Korean War MIAs Identified: The Defense POW/MIA Office announced the identification of remains belonging to Army Pvt. Donald D. Owens, 19, of Cleveland, and Army Cpl. James S. Murray, 22, of Shinnston, W.Va.

- \* In late September 1944, Private Owens' unit, the 773rd Tank Battalion, was fighting its way to France's eastern border. On Oct. 9, 1944, in the final battle for control of the region, Owens and four other soldiers were attacked by enemy fire in their M-10 Tank Destroyer. Two men survived with serious injuries but three others, including Owens, were reported to have been killed.
- \* After the 1953 Korean War armistice, surviving POWs said Corporal Murray had been captured in January 1951 and marched north to a POW camp near Suan County, North Korea, but he died while in captivity during an allied air raid a few months later.

WWII MIA Identified: The Defense POW/MIA Office announced the identification of remains belonging to Army Pfc. William F. Stehlin of Dayton, KY; he was buried on August 11 in Arlington National Cemetery. On Nov. 20, 1944, Stehlin, as part of the 333rd Infantry Regiment, 84th Infantry Division, went missing near Suggerath while his unit conducted a largely successful offensive to capture towns in Western Germany. In 1951, after an extensive search, his remains were determined unrecoverable by U.S. Army Graves Registration personnel. Today, more than 73,000 are unaccounted-for from the conflict.

### North Korea MIA Recoveries to Resume

U.S. and North Korean officials reached an arrangement last week to resume operations to recover the remains of American servicemen missing from the Korean War. The recovery operations are expected to begin in Unsan County, about 60 miles north of Pyongyang, and in the Chosin/Jangjin Reservoir area, where more than 2,000 soldiers and Marines are believed to be missing.

The U.S. had halted its recovery missions in 2005 due to increased tensions on the Korean Peninsula. The new arrangement is a stand-alone humanitarian matter that is not tied to any other issue between the two countries. Almost 8,000 American servicemen are listed as MIA from the Korean War. More than 5,500 of them are believed to be missing in North Korea.

# VFW Asks America to Remember MIA Families

America's list of missing consists of more than 83,000

WASHINGTON – As Americans gather this Friday to commemorate National POW/MIA Recognition Day, the country's oldest and largest major combat veterans' organization wants America to also remember the families of more than 83,000 missing since World War II.

"The war continues every day for MIA families, even though almost seven decades have passed for many," said Richard L. DeNoyer, the new national commander of the 2 million-member Veterans of Foreign Wars of the U.S. and its Auxiliaries.

"Every day the families relive the moment they were first notified, and every day they continue to hold out hope that new information will be uncovered that will lead to the recovery and return of their loved one," he said. "The responsibility is on all of us to never forget those who gave the ultimate sacrifice, and to comfort and support those who still grieve in silence."

DeNoyer, a retired Marine and Vietnam combat veteran from Middleton, Mass., said that because the number of missing is so great, the circumstance of loss so catastrophic, and the location of loss so vast, that the odds are tremendously against America to recover everyone, but he said that monumental challenge just strengthens the VFW's resolve and support of U.S. military and government organizations involved in the Full Accounting Mission.

# VFW Thanks Russia For Renewed POW/MIA Support

Work to return missing Americans unmatched by any veterans' organization

The national commander of the Veterans of Foreign Wars of the U.S. returned this week from a trip to Europe to meet with Russian officials regarding their revitalized support of America's POW/MIA mission, and to meet with U.S. troops stationed in Italy to discuss how VFW can better serve them and their families.

In Moscow, Richard L. DeNoyer met with the leadership of the Committee for Veterans Affairs in the State Duma and the Russian Federation Council Committee for Security and Defense, as well as with Yekaterina Priyezzheva, the new Russian co-chair of the U.S. Russia Joint Commission on POW/MIAs. Ms. Priyezzheva was appointed in June along with 31 other commissioners after the VFW earlier this year led an effort by seven U.S. veteran and POW/MIA family organizations to write Russian President Dmitry Medvedev to ask him to restore his side of the joint presidential commission, which was created in 1992 by former Presidents George H.W. Bush and Boris Yeltsin.

"Russia's cooperation is vital to gaining access to eyewitnesses and to documents inside their central military archives that could help to determine the fate of possibly thousands of missing Americans dating back to World War II," said DeNoyer, who was the eighth consecutive VFW national commander to journey to Russia on a veteran-to-veteran initiative to help account for missing Americans.

This trip followed one he made to the People's Republic of China in July to help U.S. researchers gain further access into China's military archives, and a February visit to Thailand, Vietnam, Laos and Cambodia to meet and thank American military and civilians assigned to the Joint POW/MIA Accounting Command, who do the onsite investigations and recoveries.

"I am proud of the VFW's lead role in helping to account for our missing servicemen," said DeNoyer, a retired Marine and Vietnam combat veteran from Middleton, Mass. "There is a renewed sense of support in Russia to account not only for missing Americans, but for 270 missing Russians from their war in Afghanistan. I believe the continued involvement of the VFW has played a tremendous role in making this happen, as well as our professional relationships with their veterans' organizations, the Combat Brotherhood and the War Veterans' Committee."

Accompanied by VFW Washington Officer Executive Director Robert E. Wallace, DeNoyer also met with Deputy Chief of Mission Sheila Gwaltney at the U.S. Embassy in Moscow, were briefed on political-military issues by the U.S. Defense Attaché, Rear Admiral Douglas Venlet, and were able to meet with the Marine Security Guard Detachment.

In Italy, he received update briefings by U.S. Army Garrison-Vicenza and U.S. Army Africa, as well as installation tours of the medical clinic and warrior transition unit, along with lunch with the troops and dinner with local VFW Post 8862.

Prior to returning to the States, he stopped briefly in France to lay a VFW wreath at the American Cemetery in Normandy to commemorate the 67th anniversary of the D-Day landing.

"Overseas trips are vitally necessary because of VFW's international work on the POW/MIA issue, which is unmatched by any other veterans' organization," said DeNoyer. "Plus it's a great opportunity to personally express our entire organization's appreciation to our military and civilian personnel serving around the world, and to thank our overseas VFW comrades for what they do daily to support the troops and their families."

more than 73,000 from World War II, 8,000 from Korea, 1,680 from Vietnam, 120 from the Cold War, and one each in Iraq and Afghanistan.

Leading the operational search and recovery effort is the Hawaii-based Joint POW/MIA Accounting Command. They are supported by the Defense POW/Missing Personnel Office - which provides archival research and analysis and overall policy guidance - as well as the U.S-Russia Joint Commission on POW/MIAs, the Armed Forces DNA Identification Laboratory, the Air Force Life Science Equipment Laboratory, the Defense Intelligence Agency, the U.S. State Department, individual service

casualty officers, and the military services who augment the JPAC teams with linguists and specialists trained in everything from combat medicine and explosive ordinance disposal to mountain climbing and deep sea diving.

DeNoyer said the VFW and family organizations - such as the National League of POW/MIA Families assist U.S. government search efforts by opening doors politicians and bureaucrats cannot.

The VFW has traveled to Vietnam annually since 1991 to meet with their military veterans as well as their political leadership to stress the humanitarian aspect of the Full Accounting Mission.

Annual trips to Russia were added in 2004, which will hopefully enhance archival research efforts and finding eyewitnesses who may have information on hundreds if not thousands of Americans who disappeared behind the old Iron Curtain. Visits to the People's Republic of China were also added over the past few years, as well.

"The door the VFW opens is through an open exchange focused entirely on one goal - to help return our fallen to their families. Our relationship with foreign veterans' organizations is based on mutual recognition and acceptance because, politics aside, a vet is a vet, and all who have worn the uniform of their

country understand a soldier's promise to never leave a fallen comrade on the battlefield," he said.

"America's Full Accounting Mission is a nonpolitical, humanitarian mission at its soul," said DeNoyer. "It is a national priority that President Obama and his predecessors have pledged to continue until we have achieved the fullest possible accounting of all our missing Americans. We do this mission to honor our pledge to the fallen; we do this mission to reaffirm to those currently serving that America will bring you home; and ultimately, America conducts this worldwide humanitarian mission to support American families who also served and sacrificed."


